LAST DAY TO FILE CLAIMS ("BAR DATE") IS JUNE 15, 2018

Dear Investors and Creditors:

On April 16, 2018, the Honorable Judge William P. Dimitrouleas, United States District Judge for the Southern District of Florida entered an Order approving a claims procedure which will allow you to present to the Receiver a claim for losses which you believe you have suffered in connection with your investments in **ETOPIA**.

Filing Proof of Claim and Investor Release Forms

All investors who seek to be eligible for recoveries from the Elm Entities must submit to the Receiver a Proof of Claim ("POC") form and an Investor Release Form. Copies of the forms are enclosed. You must deliver the fully completed and signed POC and Investor Release Form by mail addressed to Grisel Alonso, Receiver, Michael Moecker & Associates, Inc., 1883 Marina Mile Blvd., Suite 106, Fort Lauderdale, FL 33315. The POC must be completed and signed by each person making the claim under penalty of perjury. Copies of documents which prove your payments (investment) to **ETOPIA** must be attached to your POC. For example, cancelled checks, wire transfer receipts, and bank or brokerage account statements must be provided.

NOTE: PLEASE DO NOT FILE THE POC AND INVESTOR RELEASE FORMS DIRECTLY WITH THE COURT. INVESTORS OF RECORD ARE ONLY TO FILE CLAIMS FOR FUNDS INVESTED IN ETOPIA. IF YOU HAVE ALREADY FILED CLAIMS AND DO NOT HAVE ADDITIONAL CLAIMS TO SUBMIT RELATED TO ETOPIA, OR IF YOU HAVE ALREADY FILED CLAIMS RELATED TO ETOPIA, IT IS NOT NECESSARY TO FILE ANOTHER CLAIM NOW.

Claims Bar Date

THIS LETTER CONSTITUTES NOTICE THAT THE FULLY COMPLETED AND SIGNED POC AND INVESTOR RELEASE FORMS MUST BE RECEIVED BY THE RECEIVER BY 5:00 P.M. ON JUNE 15, 2018 ("BAR DATE"), IN ORDER FOR YOUR CLAIM TO BE DEEMED "FILED."

IF YOU FAIL TO DELIVER A COMPLETED POC AND INVESTOR RELEASE FORM, SIGNED UNDER PENALTY OF PERJURY, BY THE BAR DATE, YOUR CLAIM MAY BE REJECTED.
